PARENT/GUARDIAN AFFIDAVIT

I, _____ (Parent/Guardian) of the above named student(s), declare my intent to home school my student(s). I understand and agree:

1. To provide instruction in the subjects the Utah State Board of Education requires to be taught in public schools.
2. To provide instruction for 180 days and 990 hours each year.
3. I am solely responsible for selecting instructional materials and textbooks.
4. I am solely responsible for setting the time, place and method of instruction.
5. I am solely responsible for testing or otherwise evaluating the home school instruction my student receives.
6. If my student is home schooled, he/she may only earn school district credit consistent with school district policies.

I accept full responsibility for my student and understand that he/she may not qualify for a high school diploma issued by the Emery School District or any of its schools.

(For students with IEP's or identified through child find): My decision to home school does not in any way imply that the school district did not provide a free and appropriate public education and I understand and agree that my student has no individual right to receive some or all of the special education and related services he would receive if enrolled in a public school in the Emery School District, unless I have arranged for dual enrollment consistent with state law, Section 53A-11-102.5 and Utah State Board of Education rule, R277-438.

I have read this agreement and understand my obligations as a home school parent.
